## III. APPROVAL OF May 3, 2012 & June 7, 2012 MINUTES

Chairman Barcelona stated that without the presence of a quorum of Commissioners, no corrections or amendments to the minutes of the May 3, 2012 meeting could be made.



## IV. CHAIRMAN/ EXECUTIVE DIRECTOR'S REPORT

Executive Director Eng stated that the County's budget deliberation will begin on Monday June 25, 2012.

## V. TASK FORCE REPORTS

#### 1. Civil Service Reform-- Commissioner Hinsche Otto

Executive Director Eng stated that the task force has spent the last three weeks gathering and analyzing more data. Executive Director Eng reported that he conducted approximately half a dozen interviews with past Hearing Officers who are no longer under the new Master Contract. Executive Director Eng stated that the task force is now in the process of drafting the final report and he is hopeful that a final draft report will be available to the Commission for review at least 3 days before the July 12 meeting, the date in which the Commission will be asked to approve the report for submission to the Board of Supervisors.

## 2. Assessing e-Government Process in Los Angeles County -- Commissioner Kalm

Executive Director Eng stated that the task force has agreed to a project scope of assessing e-government processes in Los Angeles County. He explained that e-Government is the process of using the internet to deliver government information and services to its citizens. Executive Director Eng stated that up to this point, most government agencies have provided an access-only type of function to its citizens, i.e., pushing information over the internet for access by its constituents. However, this project will focus more on how Los Angeles County is progressing from one that allows passive information access to one that involves active citizen participation. Executive Director Eng stated that this represents a more transactional type of two-way communications in which a citizen can engage in dialogue, post problems, or make requests directly to an agency using the technology of his or her choice. Executive Director Eng stated that this project will mostly focus on 2 delivery models of e-Government: (1) Government-to-Business (G2B) and (2) Government-to-Citizen (G2C). He stated that the task force has already met with a couple of departments including the Department of Public Works and Regional Planning. He stated that the task force will also be reviewing other secondary research data as related to what other countries, counties, and cities are doing in the areas of e-Government.
