FORMER DISTRICT ATTORNEY ROBERT H. PHILIBOSIAN RE-ELECTED TO HIS SIXTH TERM AS CHAIRMAN OF THE LOS ANGELES COUNTY CITIZENS' ECONOMY AND EFFICIENCY COMMISSION

At its January 2005 meeting the Los Angeles County Citizen's Economy and Efficiency Commission recognized the contributions of Robert H. Philibosian to the Commission by electing him to his sixth term as Chairman.

In accepting his reelection as chairman Mr. Philibosian remarked, "The accomplishments of the Commission over the past year have clearly demonstrated the dedication and commitment of its commissioners to the improvement of local government. It is our sincere desire and our pledge to the residents of Los Angeles County to continue our work to improve the efficiency and effectiveness of County operations."

Mr. Philibosian, an appointee to the Commission of Supervisor Don Knabe, has previously served as the County's District Attorney after being Chief Assistant and Chief Deputy California Attorney General. Mr. Philibosian is currently a partner with the law firm Sheppard, Mullin, Richter & Hampton LLP.

He received his undergraduate degree in political science from Stanford University and his Juris Doctorate from Southwestern University School of Law. Mr. Philibosian is a former commissioner with the California State World Trade Commission and the former Chairman of the California Council on Criminal Justice. He is a trustee for Southwestern University School of Law and is the former Chairman of the Ad Hoc Hearing Body on Governance for the County Department of Health Services.

The Economy and Efficiency Commission has twenty-one members. Each of the five members of the Board of Supervisors appoints four commissioners to the Commission for a two-year term which may be extended by reappointment. The previous year's Grand Jury Foreperson is appointed by the Board as the Commission's 21st member. Created in 1964, the Commission is charged with reviewing all aspects of local government management, operations and policies. It submits recommendations directly to the Board of Supervisors with the objective of improving the economy, efficiency and effectiveness of local government. The members of the Commission offer their time to the County on a voluntary basis and serve without pay.
